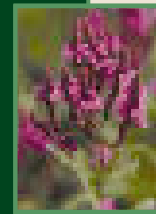
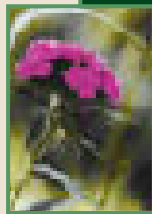

MISSION STATEMENT

The Georgian Bay Land Trust seeks to preserve the unique archipelago and its adjacent water bodies which lie along the eastern shore and North Channel of Georgian Bay that are of ecological, geological and historical importance, and to promote the appreciation of this special area.

The Georgian Bay Land Trust (GBLT) celebrates the beginning of its second decade with this its first annual report. Since its founding in 1991, the Land Trust has received ten properties with a total of just over 550 acres for long-term protection and preservation.

During this time, much creative thinking and thoughtful investigation have built a framework for GBLT, one of the first Land Trusts in Ontario. We now have policies for accepting and stewarding land, procedures for evaluating land under consideration and environmental inventories documenting important aspects of the land under stewardship.

Stewardship of the properties is shared by the Land Trust and local residents, thus ensuring that the property is used as intended. In this way important species are protected with adequate land as well as corridors necessary for their survival.

Working with other Land Trusts in Ontario, GBLT has been a leader in advocating with government to accomplish tax incentives and government policies which support both the acquisition of land for preservation as well as long term support and survival of the Land Trust movement in Ontario

The Georgian Bay Land Trust has come a long way since it received its first donation ten years ago. This has been accomplished with our strong working Board and our part time staff, each of whom brings a deep love of Georgian Bay as well as his or her talent, to the mission of the Trust. The combination of dedication, depth of knowledge and high levels of energy has facilitated the early development of the Land Trust

As we advance into our second decade, we thank each one of you for the faith that you have shown in the Land Trust through your gifts in the past. But we are just beginning.

As we move into the future, we seek your support in continuing the important mission of preserving and protecting our unique heritage in Georgian Bay.

By any measure, GBLT has been spectacularly successful in its first ten years of operation. Members, donations and acres protected are all up significantly (as you will read elsewhere in the report). But our success can also be seen in other areas. Your land trust has developed relationships and partnerships in many of the Bay's communities, and with groups such as the Nature Conservancy of Canada. Its leadership position within the industry speaks to a true maturing of your land trust. Much has been done but much more remains to be done.

In my role as Executive Director (part-time) I have been pleased to see a substantial increase in GBLT's capacity to acquire and steward land. While at first blush it may seem to be a relatively straightforward task, in reality it is quite complex. To properly inspect, consider, evaluate and accept any property we require many experts. Lawyers, appraisers, surveyors, tax experts and biologists are all becoming our regular contacts. All of which costs money and takes time, but GBLT is here for the long term and all actions must be documented.

It is part of my responsibility to ensure that the systems are in place, that all of our properties and interests are well documented and that the properties are taken care of. After all, we now have well over \$2 million in 10 properties with many more properties under consideration. These systems - and our operations in general - conform to the Standards and Practices of the Ontario Land Trust Alliance (OLTA).

The final piece of this process is gathering and prioritizing the science of the Bay in order to identify and set priorities. I am pleased to report that we started using this data in 2001. The data, its analysis and the priorities that come out of it all speak again to the issue of capacity and GBLT's principled and planned growth of fulfilling its mission.

It has been a delight and inspiration to be involved with GBLT as it is now just starting to realize its true potential.

THE COMMITTEE
HAS THE FOLLOWING
MANDATE:

To identify potential properties for land protection through donation, purchase and conservation easements.

To conduct site inspections and evaluations of these properties to ensure they meet with the following criteria:

- *Landscape value*
- *Natural value*
- *Scientific and educational value*
- *Minimum external interference*
- *No adverse conditions on the land*

To make recommendations to the board of directors on properties deemed to fit the above criteria.

To manage the process of acquiring properties, including:

- *Legal review of all transactions*
- *Having appraisals performed when necessary*
- *Ensuring appropriate ongoing stewardship of all Trust properties*

To maintain accurate records and documentation for each property, including:

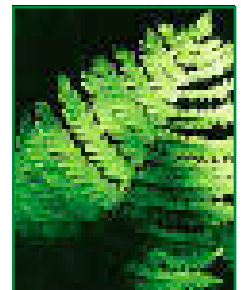
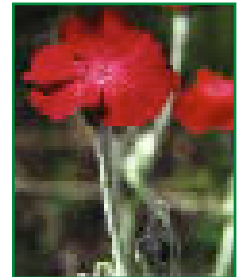
- *A property summary report*
- *A map of the property boundaries*
- *Photographs of the property*
- *All legal documents relating to the acquisition*
- *An annual review checklist of inspections by the stewards*

ACQUIRING:

The committee has invested a great deal of time and effort to ensure that the process of identifying, assessing, recommending and acquiring potential properties is conducted properly. Through the committee's efforts, and with the help of many other members of the board, we have been successful in acquiring the following properties and conservation easements in the past year:

- *Eleven acres in Bayfield Nares*
- *Mackenzie Point - Pointe au Baril*
- *Lizard Island - Cognashene*
- *South East Wooded Pine Island - outside Go Home Bay*
- *Blackstone Reserve - Blackstone Lake*
- *Truax Island - Sans Souci*
- *Umbrella Island - Sans Souci*
- *Sans Souci Hotel Property*
- *Harrison Island - Pointe au Baril*
- *Friend Island*

We also have developed a working list of 14 other potential properties for acquisition, which are in various stages of progress.



PERMITTED USES:

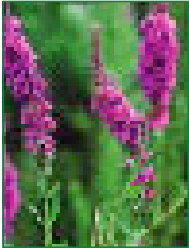
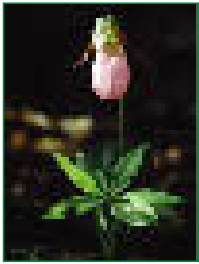
The committee has developed guidelines for the stewardship of its lands. The following recreational pursuits are acceptable...

- *Sunbathing*
- *Walking*
- *Swimming*
- *Picnicking*
- *Observing nature*
- *Taking photos and painting pictures*
- *Skiing and snowshoeing over the islands*

PROHIBITED USES:

The following activities are deemed to be destructive and not acceptable...

- *No mechanical vehicles (trailbikes, ATVs, snowmobiles)*
- *No large groups or commercialized functions (weddings parties, campgroups, etc.)*
- *No littering*
- *No fires*
- *No cutting or removal of plants, firewood, rocks, sand etc.*
- *No harassment of animal life*
- *No hunting or trapping*
- *No construction of facilities – docks, picnic tables, tent platforms, toilet facilities, etc.*
- *No damage or defacing of rocks (mooring rings, etc.)*
- *No loud noise disturbances*



USES TO BE DETERMINED ON INDIVIDUAL CASES:

Because each parcel of land is unique in its size, formation and situation special uses may be allowed...

- *Fishing (catch and release promoted)*
- *Camping*
- *Overnight mooring*

We ask our members and visitors to our properties please to be observant of these rules and regulations. These are low intensity, non-consumptive recreational uses, compatible with the preservation of natural landscapes and ecological features of these unique and fragile properties.



The *Georgian Bay Land Trust* became a partner in the Natural Heritage Inventory of the Great Lakes Heritage Coast in May 2001 forming the Georgian Bay Coast Project. This is a shared partnership with the Ontario Ministry of Natural Resources (OMNR South Central Region, Natural Heritage Information Centre) and the Nature Conservancy of Canada (NCC).

The primary purpose of this project is to collect data on the vegetation community and vascular plant species as well as on sightings of the bird, mammal, reptile and amphibian populations. The *GBLT* will use the inventory to assess the natural value of lands they might acquire in order to preserve and protect the natural heritage of the Bay.

The scope of the survey includes designated natural areas and some private lands (by consent) from the Severn River as far north as Franklin Island. The area northward to the French River is being surveyed in 2002.

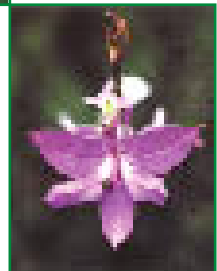
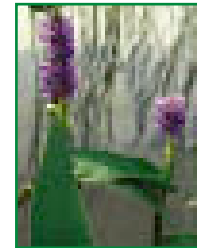
The *Georgian Bay Land Trust* provided the funding to hire Nature Heritage Inventory Centre (NHIC) contract biologist Rosita Ben-Oliel to conduct several weeks of inventory work. Part of her time was spent conducting detailed inventories on several private properties identified by the *Georgian Bay Land Trust*.

These properties are being considered for acquisition by the *Land Trust*, either through purchase or owner-initiated conservation easement. Because many sites with significant natural values in the eastern Georgian Bay area are privately

owned, the preservation and protection of these private lands play an important role in the overall conservation of natural heritage features in the region.

Data collected during the field season will be entered in the NHIC database including new data for natural areas and provincially rare species. Life science check sheets will be prepared for *GBLT* sites. These will form the basis for a comprehensive thematic summary report on the area, as well as being used for land stewardship planning and management.

The Georgian Bay Coast Project is an ongoing research undertaking in partnership with government organizations, which will continue to direct the *Land Trust* in its search for and acquisition of significant properties along the Eastern shore of the Bay.

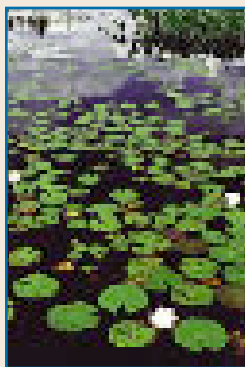
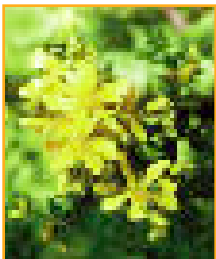

The *Georgian Bay Land Trust* recently completed a Memorandum of Understanding with the *Nature Conservancy of Canada* creating a Joint Venture arrangement with the following objectives:

- *Establishing a stewardship fund through a multi-million dollar fundraising campaign, in conjunction with the NCC's national Great Places campaign.*
- *Preservation and stewardship of ecologically significant properties now held by the Trust and those acquired in the future.*
- *Acquiring properties and easements throughout Georgian Bay through donations and, in some cases, through purchases.*
- *Conducting mapping and scientific research in Georgian Bay to identify the areas and properties most in need of protection.*



Through the Joint Venture, the *NCC* and the *GBLT* have developed detailed property acquisition criteria, including the extent and diversity of vegetation types and species, current conditions, ecological considerations, special features and aquatic habitat.

Generally, title to properties acquired through the Joint Venture will be held by the *Trust*, subject to a stewardship agreement with *NCC*. Suitable funds will be set aside in a *Trust* endowment fund to pay the ongoing costs of each property. In this way, the *Trust* and *NCC* will ensure that the property is held and appropriately preserved in perpetuity.

As a part of the Joint Venture, *NCC* has transferred ownership to the *Trust* of Mackenzie Point in Pointe au Baril and South-East Wooded Pine in Go-Home Bay. Endowment funds have been set aside for their permanent preservation.

The Joint Venture is just beginning and you will be hearing more from the *Trust* about the successes of the Joint Venture over the next few years.

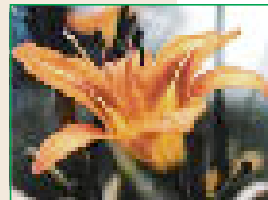
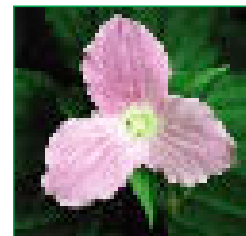
The new brochure, developed with strong art direction from *Paul Jarvis*, has been very well received.

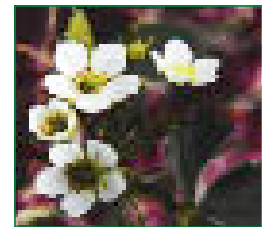
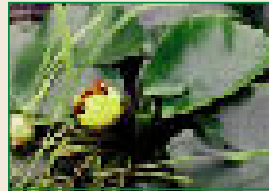

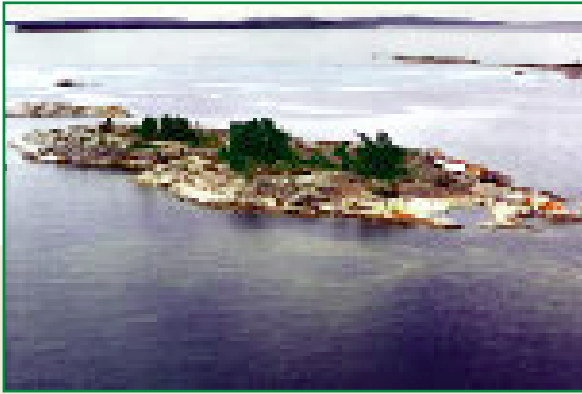

These founders contributed to the formation of the Joint Venture between NCC and GBLT - the *Georgian Bay Legacy Fund*.



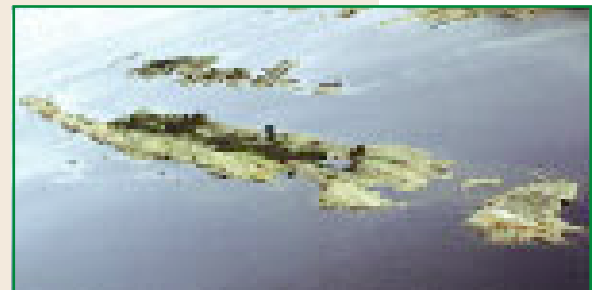
- **Property Name:** *Umbrella Island* – **Location:** *Sans Souci* – **Size:** 9.5 acres
Date Acquired: 1997 – **Natural Features:** well treed with representative pine / undisturbed outer island / excellent rattlesnake habitat – **History:** The largest of an archipelago of islands, situated about 5 km west of Sans Souci in the open, GBLT spent three years in fundraising to acquire this unique island. Lieutenant Governor Hilary Weston dedicated the island in a colourful and well-attended ceremony.

- **Property Name:** *Hotel Site* – **Location:** *Sans Souci* – **Size:** 8.42 acres
Date Acquired: 1994 – **Natural Features:** regenerating habitat / culturally significant site to Georgian Bay / Black-Throated Warbler habitat – **History:** This was the site of the former Sans Souci Hotel until the mid-1920's (as featured in the book *Island Odyssey*). GBLT was able to purchase this site after a significant donor came forward.

- **Property Name:** *Truax* – **Location:** *Sans Souci* – **Size:** 1.5 acres
Date Acquired: 2001 – **Natural Features:** outer island / unique rock types and formations
History: This small (but developable) island was GBLT's first conservation easement with a private landowner. Has been a featured site by a noted artist for its rock formations.

- **Property Name:** *South-East Wooded Pine* – **Location:** *Go Home Bay* – **Size:** 7 acres
Date Acquired: 2001 – **Natural Features:** outer island with unique rock formations / breeding bird habitat / extremely flat island – **History:** Culturally significant (painted by most of the Group of Seven), this property was originally donated to the Nature Conservancy of Canada (NCC) who in turn transferred it to GBLT for stewardship and management.

- **Property Name:** *Mackenzie Point* – **Location:** *Pointe au Baril* – **Size:** 7 acres
Date Acquired: 2002 – **Natural Features:** outer island on western shore / breeding bird habitat / immediately adjacent to an Ontario Living Legacy Protected site – **History:** This property was donated to the Nature Conservancy of Canada (NCC) who in turn donated the property to GBLT for management and stewardship.



“My mother Joan was given the island as a wedding present many years ago by her grandfather. Her family picnicked on it many times every summer as did other local cottagers. She always thought that it was too nice an island to leave to one person. She wanted everyone to be able to enjoy it. And so before Joan died she gave it to the Nature Conservancy of Canada who then granted it to the Georgian Bay Land Trust Foundation”.

“The property which I donated to the Land Trust was purchased many years ago. After some development into private cottage lots, which created much discourse and opposing factions on the lake, Mr. Wally King contacted me with the suggestion of donating the property to the GBLT in order to preserve the property in its natural state for future generations. Upon considering his suggestion we agreed to donate this significant property to the Georgian Bay Land Trust knowing that it would be protected forever”.

“My two brothers and I donated a small island to the Land Trust many years ago through the American Conservancy. It was our feeling that the area was very attractive and a happy place for people and when the area became overcrowded this beautiful place would disappear. So we put it in the hands of an organization which would maintain it in its present condition. Although we had a paddle tennis court on the island and invited the neighbouring cottagers to enjoy a game now and again, we are shy and reticent to promote this donation too broadly”.

“The island I donated to the Trust was zoned as developable. I didn’t want anything built on it as a building would affect our privacy and our view from the adjacent island. I decided that an easement on the island would protect it from development and that the GBLT could protect it and preserve it in its natural state for future generations”.

“This island was bought by my grandfather in the 20’s as a fishing base. Our extended family has enjoyed picnicking on it for many, many years. Now we feel that the neighbouring islanders would be more able to enjoy and look after it better than our family as we are a few kilometers away. Under the Land Trust stewardship we know that this lovely island will be preserved in perpetuity for others to enjoy”.

“Because I had been summering in Pointe au Baril all my life and had picnicked on this island many times, I couldn’t bear to see further development encroaching among the islands. More cottages, boats and docks would lead to loss of privacy and freedom of picnicking. It was important for me and my family that we preserve this island from development and we feel strongly that the Georgian Bay Land Trust is doing this extremely important work for all of us”.

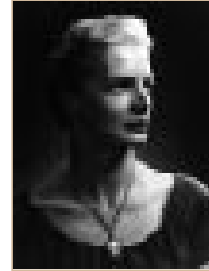

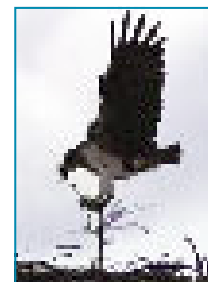

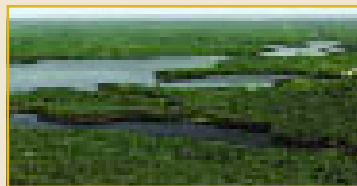
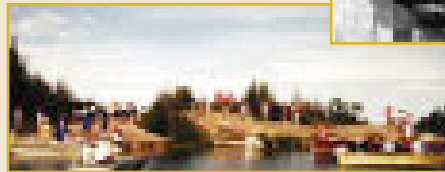


1992 - OUR FIRST PROPERTY DONATION

A 1/4 acre island - Harrison - in Bayfield Nares, is donated by a generous American.

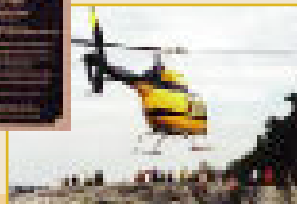
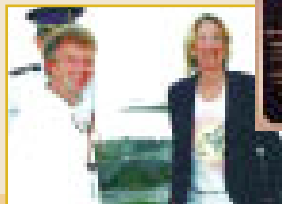
1993 - OUR SECOND PROPERTY DONATION

Blackstone Lake (approximately 300 acres) is donated by the generous Canadians Jack and Marie Nowak.



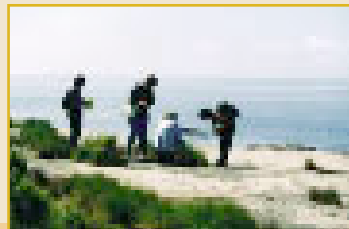
1997 - UMBRELLA ISLAND PURCHASE

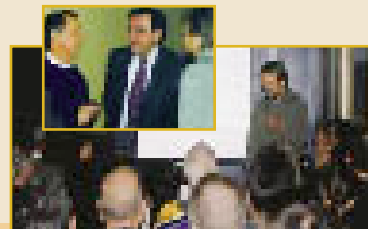
1999 - FIRST FOUNDER

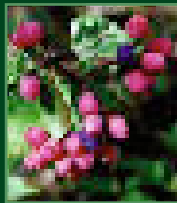
