Stewarding our Land

The Stewardship or management of the GBLT properties is designed around the idea that the best stewardship is provided by those closest to the property. GBLT staff and the Stewardship Committee decided last winter that each property should have two Stewardship co - chairs who would be responsible for their assigned property. The co-chairs are encouraged to recruit other local volunteers to help carry out the ongoing Stewardship duties. We hope that we can create a strong team for each property and by doing so we will ensure continuity and local community support for GBLT.

The duties of Stewardship are not unlike those of caring for one's own property. We ask that the stewards ensure that the signage is in good repair and standing, that garbage is removed on a regular basis, that our regulations are reasonably enforced, (no fires and no overnight camping for example) and that they observe for use and overuse patterns. We also ask the Stewards that they do an annual, written survey of their property so that we have an ongoing record of the overall condition of all of our properties.

These annual observations form the basis of our policy for each property's use for the next year. I am happy to report that each of our properties has had local Stewards in place for 2005 and the Stewardship Committee extends its thanks to all of them for their support.
